#### II. CHAIR ANNOUNCEMENTS

A. Public Comments

Dr. Patrick Smith read a letter from the Social Justice & Societal Change committee asking the board to consider a name change.

We, the members of the Social Justice and Societal Change Committee, officially support changing the name of Thomas Nelson Community College. Our College name serves as a constant reminder of, and association with, the racial oppression Thomas Nelson, Jr. perpetuated and personally benefitted from. The call for the removal of Thomas Nelson from our institutional name is not a demand to erase or change our history, but rather recognizes a more complete history, which includes the experiences of African Americans. We demand an end to the celebration of a historical figure representative of values incongruous with core values of our community college. We support this name change not as an isolated action, but as a first step in perpetuating institutional changes in our College to create a safe, respectful, and meaningful environment for all employees, students, alumni, and the residents of our community. We have carefully reviewed the facts presented about our College's namesake, Thomas Nelson, Jr. We are aware of his connection to the American Revolution and to the inception of our country's government. We know Nelson, Jr. held several important positions and offices in Virginia during his lifetime and we acknowledge these are typically the elements of a legacy that makes a historical figure such as Thomas Nelson, Jr. worthy of being immortalized in the naming of buildings or lands to be used by the public for generations to come.

However, Nelson's legacy is also that of a man who benefitted tremendously from the wealth, privilege, and position of his family. Thomas Nelson and his family came to their wealth through the enslavement of human beings, and Thomas Nelson, Jr. routinely bought and sold hundreds of enslaved people in his lifetime. This is well documented in Nelson's own papers, including his will. Thomas Nelson, Jr. vigorously advertised substantial rewards for the return, capture, or imprisonment of slaves that had fled from slavery and he did so in the newspaper of record, The Virginia Gazette. Upon Nelson's death, every one of the people he owned at that time, save his blacksmith who was granted freedom, were transferred as possessions to his family members or sold to settle Nelson's substantial debts. All of this information is publicly available.

We do not believe this institution should continue to honor a man who fought so powerfully for freedom from England, yet relegated thousands of human beings to a life of enslavement for his personal enrichment. To have our College named for someone who did not recognize the humanity of African American people and who willfully participated in the horrors of slavery throughout his lifetime is not respectful of our former and current students, faculty, staff, and surrounding community.

As one of the largest institutions in the Virginia Community College System, we take seriously our mission to change lives, empower students to succeed, and enhance the civic and economic vitality of the Peninsula. We, by signing below, respectfully ask for the College's name to be changed to demonstrate our commitment to our core values.

B. Executive Committee Meeting

The College Board Executive Committee met on January 29 and are developing a plan for the Presidential Evaluation Process. The plan includes the following:

Ms. Cieszynski and Ms. Callaway discussed the work of the College & Facilities Name Task Force. This task force is not making a recommendation to the College Board because it has 6 College Board members on it.

There were several avenues that were taken to acquire information with the goal of ensuring the College Board had sufficient information. Historical information was used and presented during several town halls to constituency groups community members, College Council, and to this College Board. This historical information was made available and posted to our website and used as part of the context for two surveys. Mr. Felker reviewed the survey results of those who chose to participate from the community and students.

Ms. Clifton informed the board of the efforts of the outreach subcommittee. This committee met with community leaders three times and discussed some of the issues from Professor Schneider's historic research.

It was moved (I. Cieszynski) and seconded (A. Melton) that the Thomas Nelson Community College Board recommends that the name of the college name be changed to a name that more appropriately reflects our geographic service area and further recommends that the that State bear the costs associated with renaming.



D. Workforce Development Update - Dr. English

Dr. English commended the workforce development group who are working through a plethora of funding opportunities that our students have. In addition to the REV funding there is also Virginia Ready which gives a \$1,000 incentive to complete the class and the credential. Recently, the state designated additional dollars to cover the first - third of a fast forward class.

As advocates within the localities, one of the great features of the Virginia ready program is a guaranteed interview with an employer. The more employers that participate in the program the more opportunities our students will have. Mr. Albertini and his workforce group have taken al of the student enrollment processes and converted them to be virtual processes.

Dr. English announced a 1.6-million-dollar grant that we were awarded. The focus of the grant is to have trade center in the Greater Williamsburg area. There is a need there so students will not have to travel to Hampton for our trade program.
